1. APOLOGIES FOR ABSENCE

2. DECLARATIONS OF INTEREST

Common Road, Llanfabon, Nelson, as she had predetermined the application due to speaking in objection as a local Ward Member. She left the meeting whilst the application was discussed and took no part in the debate or vote. Details are also minuted with the respective item.

3. **PLANNING COMMITTEE HELD ON 8TH NOVEMBER 2023**

4. **APPLICATION NO. 23/0470/FULL - LAND AT GRID REF 310441 193869, CRAIG-EVAN-LEYSHON COMMON ROAD, LLANFABON, NELSON**

Councillor B. Miles declared a personal and prejudicial interest as she had predetermined the application due to speaking in objection as a local Ward Member. She left the meeting whilst the application was discussed and took no part in the debate or vote.

The Planning Case Officer presented the application, noting that a committee site visit had been held in respect of the application, with it confirmed in the accompanying report that the recommendation in respect of the proposal had taken full account of, and was in conformity with, both Future Wales and Planning Policy Wales Edition 11.

K. Allen (Local Resident) and Councillor B. Miles (Local Ward Member) spoke in objection to the application and C. Kosaner (Agent) spoke in support of the application.

Following consideration of the application it was moved and seconded that subject to the conditions contained in the Officer's report, the recommendation be approved. By way of Microsoft Forms (and in noting there were 10 for, 1 against and 0 abstentions) this was agreed by the majority present.

Please note from the 7th January 2019, Schedule 3 of the Flood and Water Management Act 2010 commenced in Wales requiring all new developments of more than one house or where the construction area is of 100m² or more to implement sustainable drainage to manage on-site surface water. Surface water drainage systems must be designed and

built in accordance with mandatory standards for sustainable drainage published by Welsh Ministers.
