## Please outline the reasons for your Representations

Gwent police have received a full variation application from Glenn White in respect of the Project Bar ltd.

The applicant is seeking a variation to existing premises licence that will :

Extend the licensable area to include the roof terrace, to permit it to be opened during the hours Monday to Friday 12:00 to 22:00 and Saturday and Sunday 09:00 to 22:00 for the consumption of alcohol purchased from the brewery bar and to permit the sale and consumption of food.

Addition of new licensing condition:

We will erect signage encouraging customers to use the roof terrace as a smoking area instead of the public highway immediately in front of the building's main entrance, to reduce the risk of noise that could impact local residents or others using the public highway.

Amendment to existing licensing conditions (conditions 20 and 21): Re-word such that frequent patrols of the roof terrace are required to be carried out by staff in addition to the courtyard area, and that the DPS should consider the need for additional staff for monitoring the roof terrace in addition to the courtyard area. The current premises license authorises the carrying out of licensable activities Alcohol ON AND OFF a) Monday to Friday - 12.00 to 23.00 b) Saturday and Sunday - 09.00 - 23.00 c) New Year's Eve - 09.00 - 02.00 d) Bank Holidays - 09.00 - 23.00 Recorded Music a) Monday to Saturday - 16.00 to 23.00 b) New Year's Eve - 16.00 to 02.00 Late Night Refreshment a) New Year's Eve - 23.00 to 02.00 The applicant has provided several conditions at the application stage that will promote the 4 licensing objectives. Gwent Police do not object to the application but would advocate the re-wording of some of these and a small number of additional conditions that would support the applicant in the promotion of the licensing objectives.
