

## D1. FEES & CHARGES 2024/25 SUPPORTING INFORMATION

### Fees Requiring Cabinet Approval

Delegated authority for approving fees and charges increasing up to 7% to the relevant Executive Director in consultation with Portfolio holders was agreed by Cabinet in December 2023. New fees and charges or exceptions where increases are above 7% on the previous year's maximum level are detailed for Cabinet approval. Supporting information is provided below to explain the exceptional proposals and the reasonableness of the fee or charge. Cabinet are requested to review the fees listed in Appendix D2 which by law require Full Council approval.

### Fees Requiring Full Council Approval

Some fees and charges by law require Full Council approval, which include some licensing fees. This report delegates authority for approving fees and charges increasing up to 7% to the relevant Executive Director in consultation with Portfolio holders. Licence fees fall broadly into two categories. Those set by statute which the Council has no power to amend and those where the relevant statute gives Councils the power to set their fees in line with cost recovery, a cap may be set by statute in some cases. New fees that require Council approval can be found in Appendix D2.

### Public Safety

#### Community Safety Emergency

Public Safety are proposing to introduce a number of Statutory Fixed Penalty Notice charges under powers outlined within Schedule 4 of the London Local Authorities and Transport for London Act 2003. The new charges (CPN.003-CPN.012) cover a range of activities which cause obstructions to highways. The powers are to be adopted as part of the introduction of the proposed Integrated Enforcement service

### Environment and Sustainability

#### Engineering

The engineering service are proposing to introduce two new charges in respect of Approval in Principle (AIP) for highway structures.

The Approval in Principle process follows the guidelines outlined in Technical Document CG300 which replaces BD2-12. CG300 has changed the classification of the Approval in Principle Category, therefore fees have been updated to reflect the new categorisation.

The Technical Approval of Highway Structures classified as Category 0 do not require an AIP, but do require review of all information, drawings and standards used, as well as signing off the Design and Check certificate, therefore a new fee is proposed to cover Category 0 requests.

Charges have been calculated to recover projected costs associated with the activity.
