# 2 Add the following conditions:

- The premises shall implement a written dispersal policy, and a copy of the policy shall be made readily available at the premises for inspection by a police officer and/or an authorised officer.
- An incident and refusals log shall be kept at the premises for at least 12 months, and made available on request to a Police officer or an authorised officer of the licensing authority, which will record the following:
- All crimes reported to or by the premises to the Police.
- All ejections of patrons
- Any incidents of crime and disorder
- Seizures of drugs, offensive weapons, fraudulent ID or other Items
- Any faults with the CCTV system
- Any refusal of the sale of alcohol The Premises Licence Holder or nominated person shall ensure that all relevant members of staff receive

training in their responsibilities under the Licensing Act 2003. Such training shall be documented, and records made available upon request from the Police or an authorised officer of the Licensing Authority.

• A direct telephone number for the premises shall be available upon request to resident in the vicinity, to call at all times the premises are open.

# 3 Representations

- 3.1 Forty relevant representations have been received in relation to the application.
- 3.2 The representations oppose the application and are from the Licensing Authority, Licensing Police responsible authority, resident association and residents. **Appendix 4**

3.4. The times for framework hours on any given day are not (and should not be regarded as) the 'usual' or 'normal' hours for licensable activities in the Borough. Instead, the framework hours serve to identify those cases where the Licensing Authority will pay particular regard to the likely effect on the local neighbourhood of carrying out the proposed licensable activities.
