- Community pharmacies are more accessible in areas of higher deprivation. 89.2% of the population in England can access a community pharmacy within a 20-minute walk, and access is greatest in areas of highest deprivation.
- Community pharmacies in lower socioeconomic areas are more likely to offer prevention services.
- Community Connectedness and friendships community pharmacy is an untapped resource for Camden. For many communities their pharmacy is an informal resource for social and emotional support due to the accessibility of the pharmacist.

Almost all pharmacies now offer the Pharmacy First service, giving advice and, if needed, NHS medicines to treat seven common health conditions – and all without the need for a GP appointment.

Pharmacy First – launched 31st Jan 2024



- Pharmacy First (PF) launched 31st January, replacing the Community Pharmacist Consultation Service (CPCS).
- It includes all previous CPCS elements, plus 7 new clinical pathways.
- The PF service comprises three elements:

- Contractors MUST be able to provide all 3 elements (only exception is DSPs will not need to do otitis media pathway due to need to use otoscopes).
- By 31st March 2025; any contractor wishing to provide Pharmacy First must also provide Pharmacy Contraception and Hypertension Case-Finding Service.

Who can use this service...

Patients aged under 16 years who have at least one parent who would be eligible for this service

Patients who are receiving Universal Credit and whose income is at a level where they are eligible for free prescriptions.

Patients receiving any other benefits which give them eligibility for free prescriptions:

- NHS Low Income Scheme and are in possession of a valid HC2 certificate.
- Income Support (IS) or Income-related Employment and Support Allowance (ESA)
- Income-based Jobseeker's Allowance (JSA)
- Tax Credit exemption certificate
- Pension Credit Guarantee Credit

Young people aged 16,17 or 18 years and

• in full-time education, part-time education, or undertaking an accredited level 1 apprenticeship

Homeless and in possession of local authority 'Letter of homelessness'

Over 40? You need to know your blood pressure



Around 1 in 4 adults in the UK have high blood pressure, but many don't know it. It can increase your risk of having a heart attack or stroke.

Knowing what your blood pressure numbers mean could save your life.

To find out how to get checked and manage your risk, visit nhs.uk/bloodpressure



Why get your blood pressure checked?

- High blood pressure, also called hypertension, is a condition which can be controlled to reduce the risk of a heart attack, stroke or other cardiovascular disease.
- In the UK there are about five million adults (one in every nine) who have high blood pressure without even knowing it, since high blood pressure itself rarely causes symptoms.
- The British Heart Foundation estimates that high blood pressure causes over 50% of heart attacks and strokes.

What does this free NHS blood pressure check involve?

- FREE NHS blood pressure checks to people aged 40 and over with no appointment necessary.
- General practices can also refer patients to a participating community pharmacy for a clinic blood pressure reading, or for 24-hour ambulatory blood pressure monitoring.

Need a supply of oral contraception?

If you're already taking oral contraception (the pill) or looking for your first supply, you can arrange a confidential consultation at a local participating pharmacy.

This service is free for everyone, and you don't need to be registered with <u>a GP.</u>

- This free service may be more convenient than booking an appointment with the GP surgery or at a sexual health clinic.
- The pharmacist can give the same expert advice about selecting and managing contraceptive pills as the GP surgery.

Pressures Survey 2024: a picture of distress

- 64% of businesses are operating at a loss
- 16% predict they cannot survive a year
- 52% say patients are negatively impacted:
 - 94% by inability to source medicines
 - 86% by longer dispensing times
 - 79% unable to spend as much time with patients
- 90% say costs are higher:
 - 96% rising staff costs
 - 96% rising medicine costs
- Medicines procurement taking longer than ever before for over 80%
- Most businesses still experiencing staff shortages

Dear Secretary of State,

As leaders of the representative bodies for community pharmacies in England, we are writing to impress upon you the urgent need to shield community pharmacies from the increased costs and measures in the Budget on National Insurance and the National Living Wage.

The 10,450 community pharmacies in England see more patients each day than any other part of the NHS yet are facing extreme financial pressures after a decade of real-terms cuts, combined with ever-increasing costs. Pharmacies have already absorbed significant NHS activity increases against this backdrop. They are still waiting for a settlement for this financial year, even though we are now in November

Even before the Budget announcements, community pharmacies required a substantial real terms uplift, merely to prevent further damage to the network. Imposing very significant additional costs through higher employers' National Insurance Contributions and increasing the National Living Wage which will add circa £50 million and £115-152 million in costs to the sector respectively – will further undermine the already perilous position facing the pharmacy network.

You will know about pharmacy closure rates: we fear that without mitigation, these additional costs will push many more towards insolvency. More community pharmacies will be forced to cut opening hours and services, or even close their doors entirely, which will increase pressure elsewhere in the NHS and reduce access and care for the patients we all want to serve.

As you will know, around 90% of the income for an average community pharmacy comes from providing NHS services; they are no ordinary private businesses and cannot raise their prices for patients. But unlike other parts of the NHS, they have to exist in a commercial environment and balance the books in order to survive.

We wholeheartedly agree with the Government's ambition to move care into communities, increase prevention and promote healthy living and we know that community pharmacies can move at pace to make these ambitions a reality.

However, the sector needs to be put on a sustainable financial footing to achieve this. A settlement in the current year that does not cover the increased costs community pharmacies are facing. including measures outlined in the Budget - and address the ongoing recovery of margin - will

hinder the reform the Government wants to achieve and instead see community services facing further decline. We must prevent this from happening.

We very much want to work constructively with you to help deliver your mission for the NHS. We look forward to hearing from you soon regarding this pressing matter.
