

**APPENDIX D – FEES AND CHARGES FOR 2025/26**

This appendix outlines those fees and charges for which approval from Cabinet or Full Council is required in order for them to be levied from the 2025/26 financial year.

A portion of the fees and charges for 2025/26 were set as part of the Parking Policy Review in February 2024, or as part of the Update on the Council's Medium Term Financial Position in July 2024. In addition, Cabinet agreed in December 2024 to a number of fees and charges which were either new or increasing by more than 7%, as well as delegating authority for approving fees and charges increasing up to 7% to the relevant Executive Director in consultation with Portfolio Holders.

**D1. 2025/26 FEES AND CHARGES REQUIRING CABINET APPROVAL****Fees Requiring Cabinet Approval**

New fees and charges or exceptions where increases are above 7% on the previous year's maximum level are detailed for Cabinet approval, where these have not already been agreed. Supporting information is provided below to explain the exceptional proposals and the reasonableness of the fee or charge.

All fees which require Cabinet approval are given below, along with supporting narrative explaining each recommended charge.

**Digital & Data Services**

Following the reopening of the Town Hall, the Council is introducing Here's to You reception packages, which are set packages and can be customised. The lowest starting package was approved by Cabinet in December, with the other 11 packages (CUS.248-258) recommended for approval here. The report also contains a delegation to the Chief Experience & Information Officer to agree customisation options and costs on the Council's Here's to You reception packages on an individual basis.

**Environment & Sustainability**

Camden Accessible Transport Service (CATS) service is recommending the introduction of a new charge for third party usage of the Compressed Natural Gas (CNG) filling station at the Council's York Way Depot (CATS.010). Previously the filling station was operated by a third party who received the income from sales to third parties. Under a new contract awarded to TSG UK Solutions Ltd, the Council will operate the filling station and receive any income generated from third party sales.

Initially the charge will be £1.20 per kg (including VAT) plus 23% overhead to achieve full cost recovery giving a total of £1.47. The cost will vary according to market prices so the Cabinet is also asked to delegate authority to the Head of Camden Accessible Transport Services, after

consultation with the Director of Environment & Sustainability and the Director of Finance, to amend the CNG charge in line with wholesale prices, adding on VAT and 23% overhead. This charge is levied under s1 of the Localism Act 2011, the General Power of Competence.

**Recreation**

Camden provides cemetery services via a shared service with Islington Council. The service is managed by Islington staff.

There has been a refresh of the fee structures (all fees beginning with ICCS in the tables below) for the service and due to the nature of the service there are core services (burials and cremations) as well as a long list of sundry items to ensure the service can respond to individuals' burial wishes.

The core services associated to burials and cremations have been benchmarked and are on average 39% below the comparable cemeteries. Residents continue to benefit from an average 50% discount on fees.

Some of these fees are set as maximum limits because they relate to bespoke responses to support individuals' burial wishes across a wide range of options. A delegation is therefore sought to give authority to the Director of Recreation to decide fees for ICCS.070, ICCS.166, ICCS.171 and ICCS.283 up the maximum amounts.

**D2. 2025/26 FEES AND CHARGES REQUIRING FULL COUNCIL APPROVAL****Fees Requiring Full Council Approval**

Some fees and charges by law also require Full Council approval, including some licensing fees. Licensing fees fall broadly into two categories.

- i. Those set by statute, which the Council has no power to amend
- ii. Those where the relevant statute gives Councils the power to set their fees in line with cost recovery. A cap may be set by statute in some cases.

This appendix sets out those licensing fees for which Full Council approval is required.

**Economy, Regeneration & Investment**

The planning service is recommending the introduction of two new administration fees. These new charges are being introduced to cover the cost of processing refunds issued with regards to planning applications or pre-application planning advice and will be set at 2% of the fee paid, so therefore will apply to a number of fees. The maximum amounts are set out, with the maximum amount for REG.200 based on 2% of the highest-valued pre-application fee (which is £18,799) and the maximum amount of REG.201 based on 2% of the highest-valued statutory application fee (which would be £411,885 if the Draft Planning Order is implemented) respectively. Actual fee income may be less depending on the type of application fee refund requested by the customer.

In addition, this report proposes new fees linked to changes proposed to the Council's pre-application planning advice service (REG.269-273). This includes replacing a single flat rate fee for householder and listed building pre-apps and introducing a tiered system based on the scale and nature of the works, as well as a new fee for advice specifically related to basements.

**Environment & Sustainability**

New discretionary Street Trading fees (STR.001-005) have been introduced to incentivise early payment of statutory Fixed Penalty Notices (FPNs) for street trading offences. These fees have been introduced to reflect the early repayment option (which was not previously separated out in the fee structure) and have been introduced for transparency.

**Public Safety**

It is proposed that statutory fees for explosives licenses (PLA.0749-0771) are increased in line with the maximum permitted statutory fee limit.

Pavement licensing renewal or variation fees (PLA.0984) are recommended to be uplifted to reflect the new statutory cap.

It is proposed that film licensing fees (PLA.0895, PLA.0897-0898, PLA.1017) are uplifted. These proposed charges are below the levels charged by Westminster, helping the service to recover costs whilst aligning with the Council's strategy to promote arts and culture within Camden.

**D3. DRAFT PLANNING ORDER FEES AND CHARGES – FOR INFORMATION**

**Economy, Regeneration & Investment**

On 13 January, the Government laid a draft statutory instrument (The Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) (Amendment and Transitional Provision) Regulations 2025 (the ‘2025 Regulations’) before Parliament that, if brought into force, will increase a wide range of planning application fees in England. Assuming its adoption remains on track, the changes in the 2025 Regulations will take effect on 1 April 2025.

This report therefore recommends that Full Council delegate authority to the Director of Economy, Regeneration & Investment to introduce the fees set out in the 2025 Regulations should they come into force, including reconciling this with existing fees where necessary. Appendix D3 outlines those fees (REG.227-268) which would change substantially as a result of the 2025 Regulations as they currently stand and if brought into force for Members’ information, whilst noting that the Regulations remain in draft and therefore may be subject to change.
