Notes for Guidance

This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.

- 1. You do not have to pay a fee if the only purpose of the variation for which you are applying is to avoid becoming liable for the late night levy

 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.

- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

Annex 1 - Mandatory conditions

- 1. The supply of alcohol is prohibited at a time when there is no designated premises supervisor in respect of the premises.
- 2. The supply of alcohol is prohibited at a time when the designated premises supervisor does not hold a personal licence or his/her licence is suspended.
- 3. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 4. (a) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
 - (b) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 5. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 6. For the purposes of the condition set out in 5
 - (a)"duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979 (b)"permitted price" is the price found by applying the formula—

$$P = D + (DxV)$$

where-

- (i) P is the permitted price,
- (ii)D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol:
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - (i)the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii)the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e)"valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 7. Where the permitted price given by Paragraph (b) of 6 above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph



- shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 8. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 - Conditions consistent with the Operating Schedule

- 9. Alcohol shall not be sold or supplied except during permitted hours. In this condition, permitted hours means:
 - a) On weekdays 07.00 to 23.00
 - b) On Sundays 10.00 to 22.30
- 10. The above restrictions do not prohibit:
 - (a) during the first twenty minutes after the above hours, the taking of alcohol from the premises, unless the alcohol is supplied or taken in an open vessel.
 - (b) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
 - (c) the sale of alcohol to a trader or club for the purposes of the trade or club;
 - (d) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces.
- 11. Alcohol shall not be sold in an open container or be consumed in the licensed premises.

Annex 3 - Conditions attached after a hearing by the licensing authority 18/04/2012

- 12. The Licence holder shall install and maintain a closed circuit TV monitoring system. Images recorded will be retained for at least 21 days and will be handed to the police/local authority on request.
- 13. Signage will be displayed in store stating that it is an offence for people aged under 18 to purchase alcohol.
- 14. The store will be fitted with a panic button for staff to press in cases of emergency.
- 15. No deliveries to take place between the hours of 23:00 and 06:00 the following day.



- 16. All staff shall be trained in relation to underage related sales of alcohol.
- 17. A proof of ages scheme such as challenge 25 shall be in place and notices of this prominently displayed within the store.
- 18. The premises shall operate an electronic till prompt when alcohol is scanned to remind staff to check the age of the purchaser
- 19. An "Age refusals register" will be kept on the premises to record where sales of alcohol are challenged or refused.

Kentish Town Road Action is strongly opposed to this application by the Co-op to extend the sales of alcohol off the premises for 7 days a week until 2am – (alcohol to be sold from hatches) and to add a Late Night Refreshment licence for 7 days a week until 2 am – (refreshments to be sold from hatches).

The Co-operative Group has applied for a Major Variation of the premises licence in order to sell alcohol and refreshments off the premises for hours that are way past the Terminal Hours – 2 am is three hours past the Terminal Hour for off licence alcohol sales, and two hours past the Terminal Hour for Late Night Refreshment.

If this application is approved the outcome will be disastrous for Kentish Town Road and all the many residents who live on Kentish Town Road and in the houses on many of the side streets. Kentish Town Road runs through a highly built-up residential neighbourhood. There are residential flats above all the shops in the road. Leading off the high street are several streets of dense residential housing. The high street is at present fairly quiet at night but it will not remain so if this application is approved and there is the inevitable increase in motorbikes whizzing through to hatches to pick up and deliver alcohol and refreshments in the early hours.

The Prevention of Crime and disorder

The Co-op will argue that the alcohol and refreshment deliveries through hatches will be carefully controlled, but the Police will have great difficulty in managing them, especially in the early hours. There will be fights and awful disruptions.

Public Safety

There are already problems with late night drinking in Kentish Town Road. There would be a real danger of accidents, fights and worse when alcohol were to be delivered from hatches without the personal control of Licencees.

Protection of Children from Harm

It would be very difficult to carry out ID checks from underage customers outdoors at night. Who will be policing this? There could be very nasty fights around the hatches.

Kentish Town Road Action objects to this licensing application and is asking the panel to reject the application in its entirety. It seems to us to be a very cynical and exploitative attempt by the Co-operative Group to undermine Camden's licensing policies in what appears to be an underhand manner.

The Framework Hours for Alcohol and Late-Night Refreshments are there for a very good reason – to keep the streets quiet and safe at night so that residents, and especially children, can sleep undisturbed ready for school and work the next day. The application as it stands should be dismissed outright.

The Co-operative Group and Society has always stood for good values and principles. In its Mission Statement it supports local communities and their social well-being. It says it values ethical conduct, social responsibility and caring for others.

This application for supply of late-night alcohol and refreshments from hatches hardly supports these good intentions. Please turn it down.'

I am a resident in Kentish Town since 1986 and Ward councillor since 2010. I have a fairly good and intimate knowledge of the area, and of Kentish Town Road in Particular. It is a densely populated residential area - vibrant during the day and evenings, and extremely quiet and tranquil past midnight. This is thanks to the licensing framework hours prevailing in the area and protecting this tranquillity for our residents outside framework hours. Ambient

noise levels past midnight on Kentish Town Road falls away completely, so much so that even the slightest conversation reverberates and will cause noise nuisance keeping residents and their children awake. I appreciate this application for the late hours applied for past midnight will not involve sales to the public directly for collection from the store. It is for delivery only. While this will undoubtedly lessen the noise nuisance impact on residents, there is evidence from nearby premises that even electric delivery bikes will cause noise nuisance by simply conversing either on their phones or when collecting goods to deliver. Or delivery riders conversing with each other while waiting to collect deliveries. This is an evidenced fact I have observed personally, and believe cannot be mitigated by conditioning simply because premises have no jurisdiction or control over third party delivery riders outside their premises, and such conditions cannot be practicably enforced either by officers or the premises. In practice, there is no real difference between patrons spilling out of pubs being attracted to and kept in the area by these premises, and delivery riders being attracted to and kept in the area by these premises, who will cause noise nuisance and keeping residents awake. I therefore object to this application on the grounds that it will fail to promote the prevention of public nuisance policy objective. Hence, I ask that the panel reject the application outright. I would like to address the panel at the hearing as an interested party.

1. CCTV

- 1.1 The Premises Licence Holder shall install and maintain a CCTV system at the premises giving coverage of all customer entry points and areas to which customers have access in any lighting conditions.
- 1.2 The CCTV system shall be in operation whilst the premises are open for licensable activities and shall be capable of providing frontal identification of customers.
- 1.3 All CCTV recordings shall be retained for a minimum of 28 days and shall be date and time stamped.
- 1.4 CCTV recordings should be made immediately available for inspection upon receipt of a request by the Police and Authorised Officer of the Licensing Authority.
- 1.5 A member of staff shall always be present on the premises whilst they are open who is capable of operating the CCTV system and able to facilitate immediate viewing of CCTV footage upon the request of the Police and Authorised Officer of the Licensing Authority.

2. Proof of Age

2.1 A Proof of Age Scheme, such as Challenge 25, shall be operated premises whereby the only acceptable forms of identification are a valid passport, UK driving licence, any form of identification containing the PASS hologram, military identification or any other form of identification time to time approved by the Secretary of State.

3. Incident Log

3.1 An Incident Record, whether kept in written or electronic form, shall be maintained at the premises and made available on request to the Police or an Authorised Officer of the Licensing Authority. The Incident Record shall record any complaints received in connection with the licensable activity committed at the premises, any faults with the CCTV system, any refusal to sell alcohol at the premises, and any visit to the premises by a responsible authority in connection with the licensable activity permitted at the premises.

4. Training

- 4.1 All relevant staff shall be trained in relation to their responsibilities under the Licensing Act 2003
- 4.2 Training Records shall be correct and made available for inspection upon receipt of request from the Police or an Authorised Officer of the Licensing Authority.
- 4.3 No member of staff shall be permitted to sell alcohol until they have successfully completed their training.

5. Miscellaneous

- 5.1 A notice must be displayed in the premises explaining that it is an offence for persons under the age of 18 to purchase alcohol.
- 5.2 A panic alarm shall be installed and maintained at the premises.
- 5.3 A burglar alarm system shall be installed and maintained at the premises.

- 5.4 The premises shall close to the public at 2300 Mon Sat and 2230 Sunday and re-open at 0700 on the following day Mon Sat and 1000 Sun. Sales of alcohol between 2300-0200 Mon- Sat and 2230-0200 Sun shall be for on-line delivery only.
- 5.5 The Premises Licence Holder shall require any delivery partner engaged in on-line deliveries to apply a Challenge 25 policy at the point of delivery
- 5.6 No on-line deliveries shall be made to a public open space
- 5.7 An age prompt till shall be utilised at the premises.
- 5.8 A refusals record shall be maintained at the premises and shall be made available for inspection by the Police or an authorised Officer of the Local Authority.

Section 1: Background comments of the Borough Solicitor

- 1.1 The purpose of Camden's Statement of Licensing Policy is to make it clear to applicants that wider considerations will be taken into account when determining applications. It is intended to guide the Licensing Panel when considering licence applications. However, the Licensing Panel must always consider each application on its own merits and allow exceptions to the normal policy where the circumstances of the application justify allowing an exception. The burden is on the applicant to show that they comply with the policy.
- 1.2 Members should only address those matters that have formed the subject matter of relevant representations. Matters that arise that are not the subject of relevant representations fall outside the function that the Panel is exercising when it holds a hearing
- 1.3 Members must determine, having regard for the evidence, whether granting the application for a premises licence will impact adversely on the policy criteria listed in paragraph 3 of this report.
- 1.4 In accordance with the provisions of Part 1 of Schedule 5 of the Act, where a Licensing Authority rejects in whole or in part, an application for a new premises licence, the applicant may appeal against the decision, to a magistrate's court within 21 days of being notified of the decision.
- 1.5 Similarly, where a person who made relevant representations in relation to the application contends that the licence ought not to have been granted, or that different or additional conditions should have been imposed on the licence, he may appeal against the decision to a magistrate's court within 21 days of being notified of the decision.
- 1.6 The Human Rights Act 1998 incorporates the key articles of the European Convention on Human Rights into domestic law. Decisions on licensing matters are actions of a public authority and must be compatible with Convention rights. Consequently, Members of the Panel must be aware of the rights contained in the Convention (particularly those set out below) when making licensing decisions.

(a) Article 6: Right to a fair trial

In the determination of his civil rights and obligations, everyone is entitled to a fair and public hearing within a reasonable time by an independent and impartial tribunal established by law.

(b) Article 8: Right to respect for private and family life Everyone has a right to respect for his or her private life, his home and correspondence.

(c) Article 1 of the First Protocol: Protection of property
Every natural or legal person is entitled to the peaceful enjoyment
of his possessions, including a licence. No one shall be deprived of his
possession except in the public interest and subject to the conditions
provided for by law and by the general principles of international law.

(d) Article 10: Freedom of Expression

Everyone has the right to freedom of expression. This right shall include freedom to hold opinions and to receive and impart information and ideas without interference by public authority and regardless of frontiers. This Article shall not prevent States from requiring the licensing of broadcasting, television or cinema enterprises.

The exercise of these freedoms since it carries with it duties and responsibilities may be subject to such formalities, conditions, restrictions or penalties as are prescribed by law and are necessary in a democratic society, in the interests of national security, territorial integrity or public safety, for the prevention of disorder or crime, for the protection of health and morals, for the protection of the reputation or rights of others, for preventing the disclosure of information received in confidence, or for maintaining the authority and impartiality of the judiciary.

(e) Article 14: Prohibition of discrimination

The enjoyment of the rights and freedoms set forth in this Convention shall be secured without discrimination on any ground such as sex, race, colour, language, religion, political or other opinion, national or social origin, association with a national minority, property, birth, or other status.

1.7 When formulating policy local authorities must have regard to the **Equality Act 2010**. The Act provides protection from discrimination in respect of certain protected characteristics, namely: age, disability, gender reassignment, pregnancy and maternity, race, religion or beliefs and sex and sexual orientation. It places the Council under a legal duty to have due regard to the advancement of equality in the exercise of its powers including licensing powers. Members of the panel must be mindful of this duty when determining all licensing applications.

The section 149 Public Sector Equality Duty

- (1)A public authority must, in the exercise of its functions, have due regard to the need to—
- (a) eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by or under this Act;
- (b) advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it;
- (c) foster good relations between persons who share a relevant protected characteristic and persons who do not share it.

- (2) A person who is not a public authority but who exercises public functions must, in the exercise of those functions, have due regard to the matters mentioned in subsection (1).
- (3) Having due regard to the need to advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it involves having due regard, in particular, to the need to—
- (a) remove or minimise disadvantages suffered by persons who share a relevant protected characteristic that are connected to that characteristic;
 (b) take steps to meet the needs of persons who share a relevant protected characteristic that are different from the needs of persons who do not share it;
 (c) encourage persons who share a relevant protected characteristic to participate in public life or in any other activity in which participation by such
- (4) The steps involved in meeting the needs of disabled persons that are different from the needs of persons who are not disabled include, in particular, steps to take account of disabled persons' disabilities.
- (5) Having due regard to the need to foster good relations between persons who share a relevant protected characteristic and persons who do not share it involves having due regard, in particular, to the need to—
- (a) tackle prejudice, and
- (b) promote understanding.

- (6)Compliance with the duties in this section may involve treating some persons more favourably than others; but that is not to be taken as permitting conduct that would otherwise be prohibited by or under this Act.
- 1.8 In determining any application, the Council must comply with the public sector equality duty in s.149 of the 2010 Act. This is a duty to have regard to the need to achieve the statutory goals of s.149, rather than to achieve a particular result. The s149 duty sits alongside and does not override statutory requirements in relation to determining licensing applications, including the duty to consider all evidence on its merits and the legislative criteria listed at paragraphs 3 & 4.
- 1.9 When members have before them representations or other material on issues relevant to s149, even outside the scope of "standard" licensing considerations such material must still be specifically assessed in the context of s149. However, because s149 creates a requirement to "have regard" the fact a matter raised is relevant to s149 will not automatically translate into a reason for refusing an application that would be sustainable in any subsequent appeal, given the legal requirement to determine applications in compliance with licensing legislation.
