## **1. Political Balance**

- 1.1 Following the by election held on 28<sup>th</sup> August 2025, the division of seats on the Council is as follows:-

Labour:	45
Liberal Democrat:	6
Conservative:	3
Green:	<u>1</u>
	<u>55</u>

- 1.2 Committee seats are allocated in the same proportion, or as near as is possible, unless the Council agrees to disapply proportionality. Officers have thus re-calculated proportionality on committees and sub-committee in the light of the increased size of the Liberal Democrat Group and this group is now entitled to the opposition seats on the Audit and Corporate Governance (Statutory Officers Appeal) Sub-Committee and the Audit and Corporate Governance (Accessible Transport Appeals) Sub-Committee previously occupied by the Conservative Group.

## **2. Changes to Committee Memberships**

- 2.1 Audit and Corporate Governance Committee – Councillor Dixey has stepped down from this Committee and Councillor Grauberg is nominated to fill the resulting vacancy.
- 2.2 Audit and Corporate Governance (Statutory Officers Appeal) Sub-Committee – Councillor Janet Grauberg has been nominated to the opposition seat on this sub-committee.
- 2.2 Audit and Corporate Governance (Accessible Transport Appeals) Sub-Committee – Councillor Dixey has been nominated to the opposition seat on this sub-committee.
