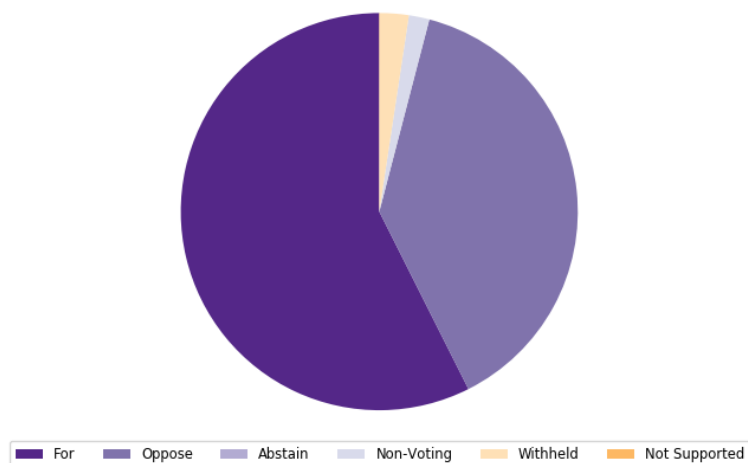

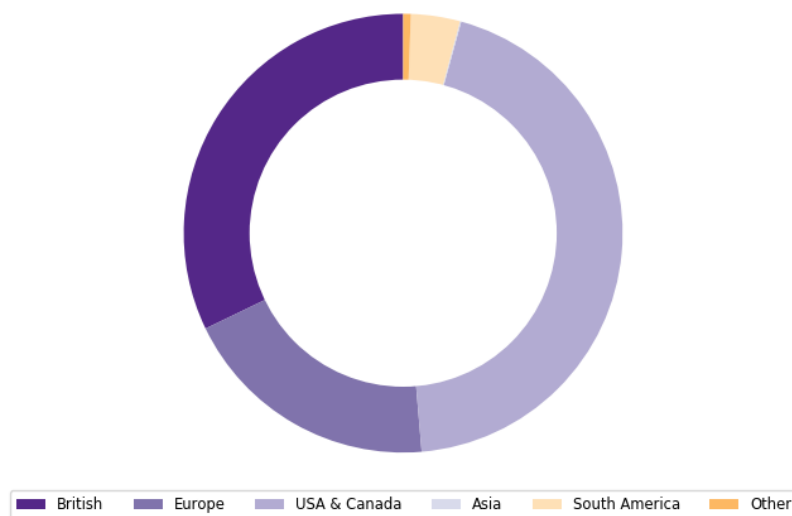

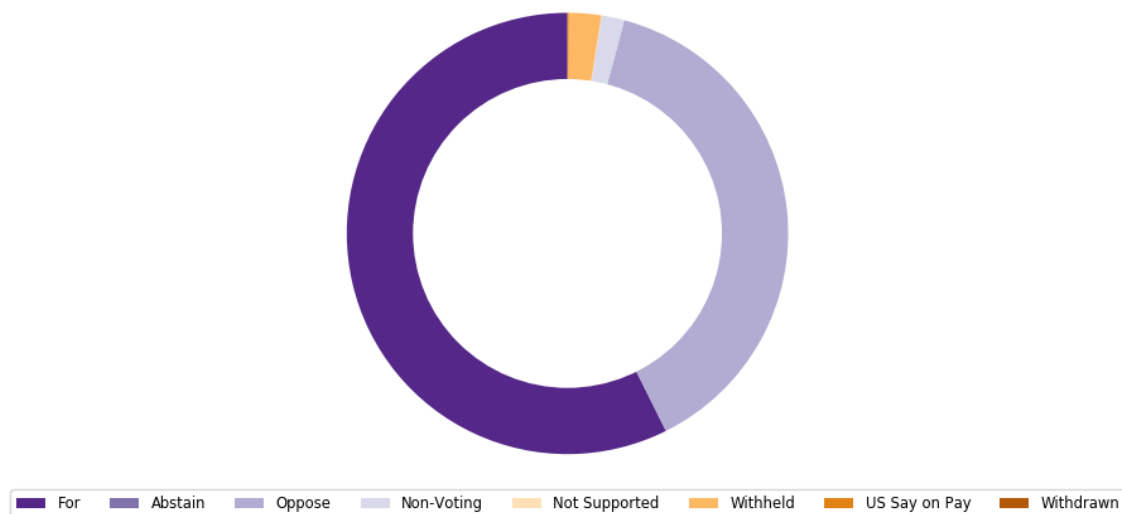
Meetings voted by geographic location

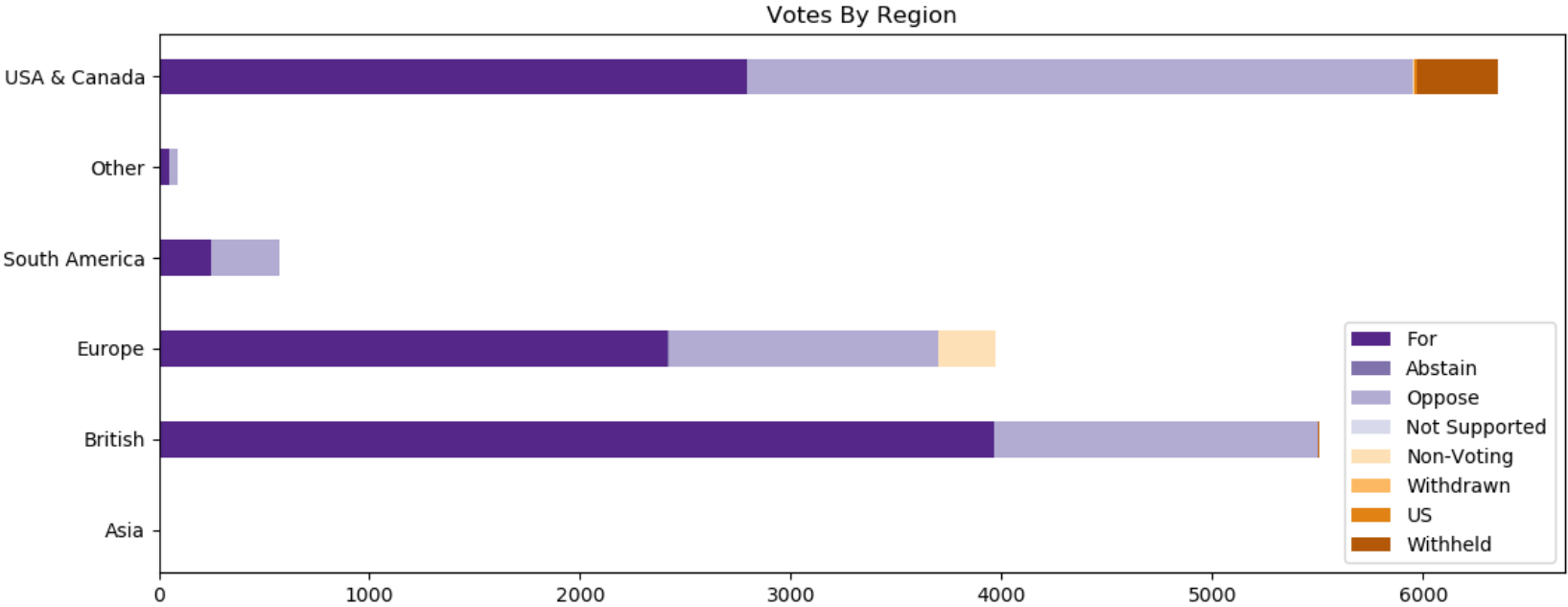

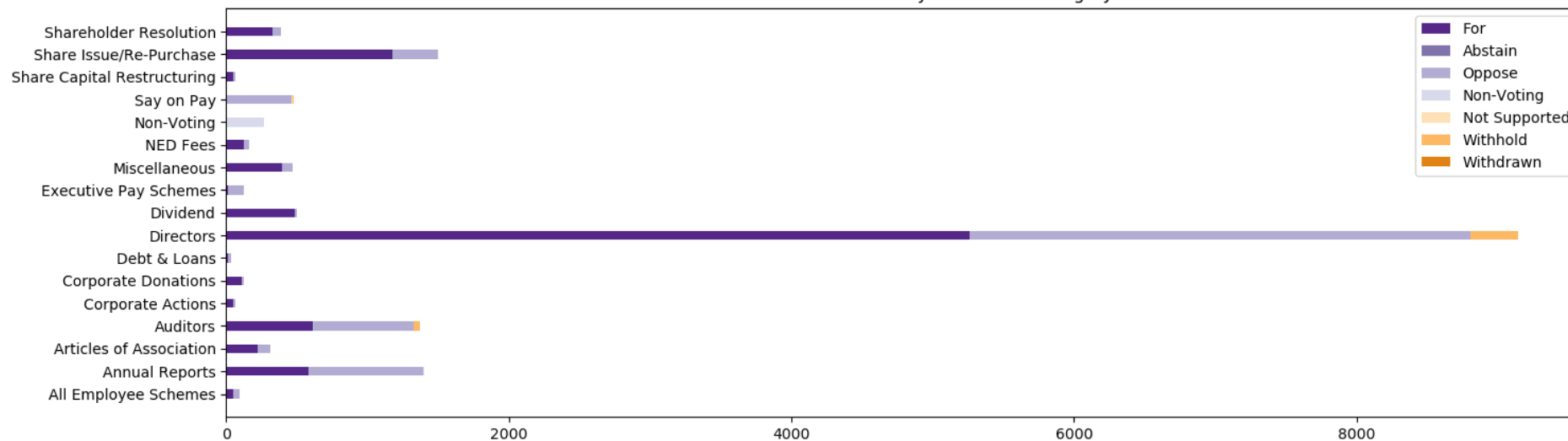

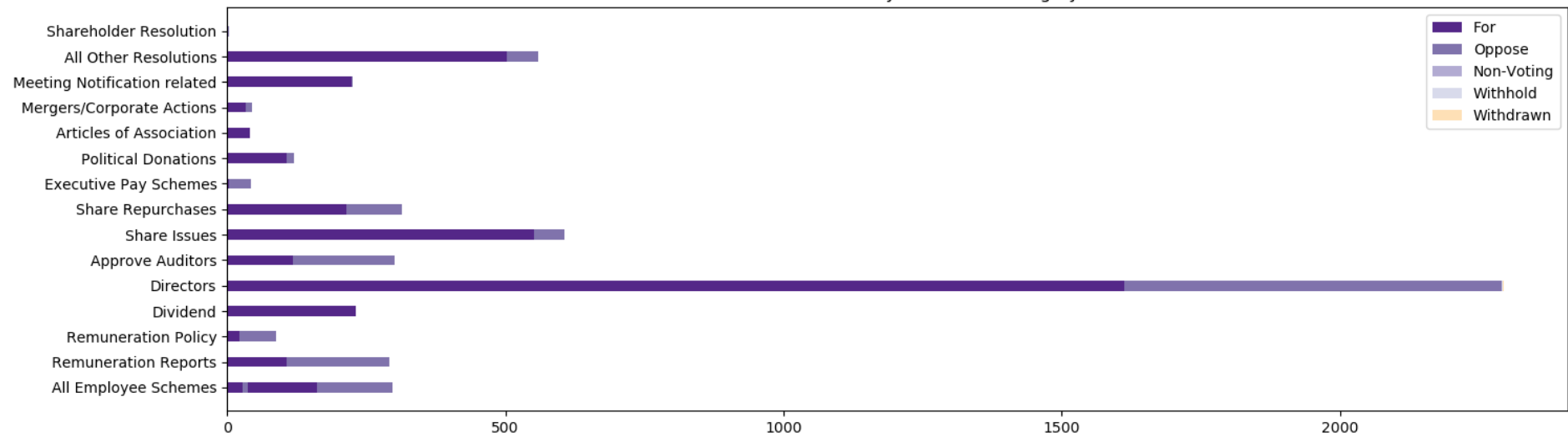
Votes Made in Portfolio by Resolution Category

Votes Made in UK by Resolution Category

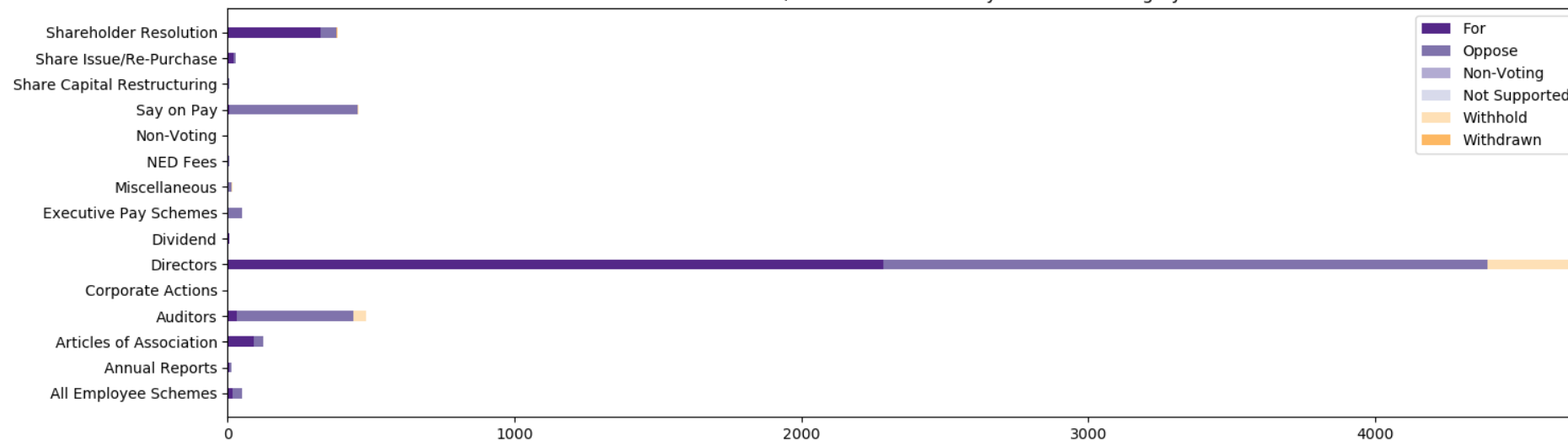

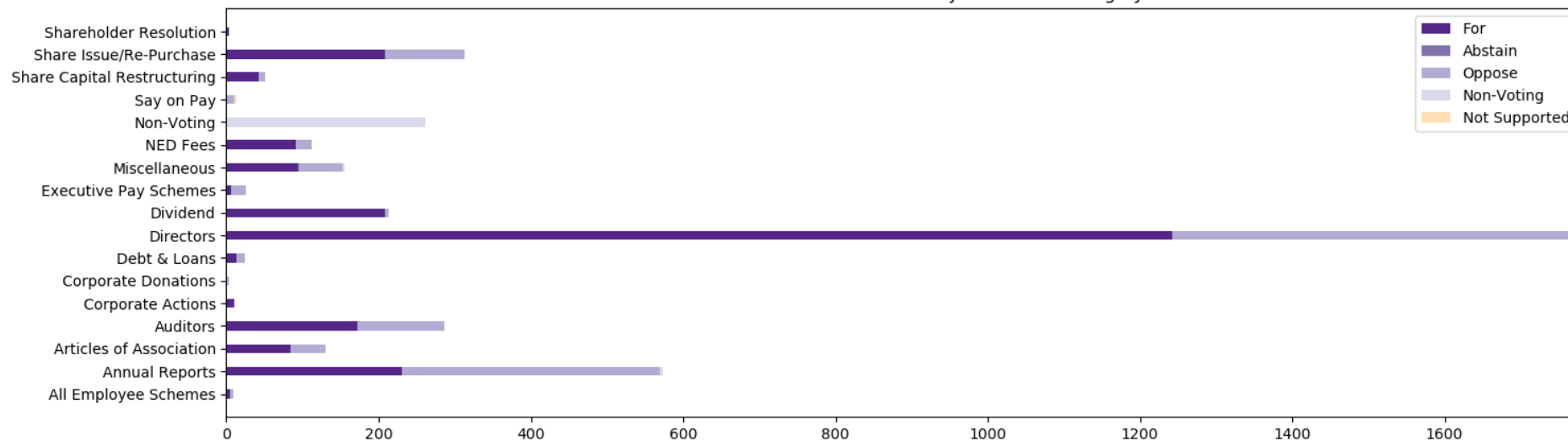

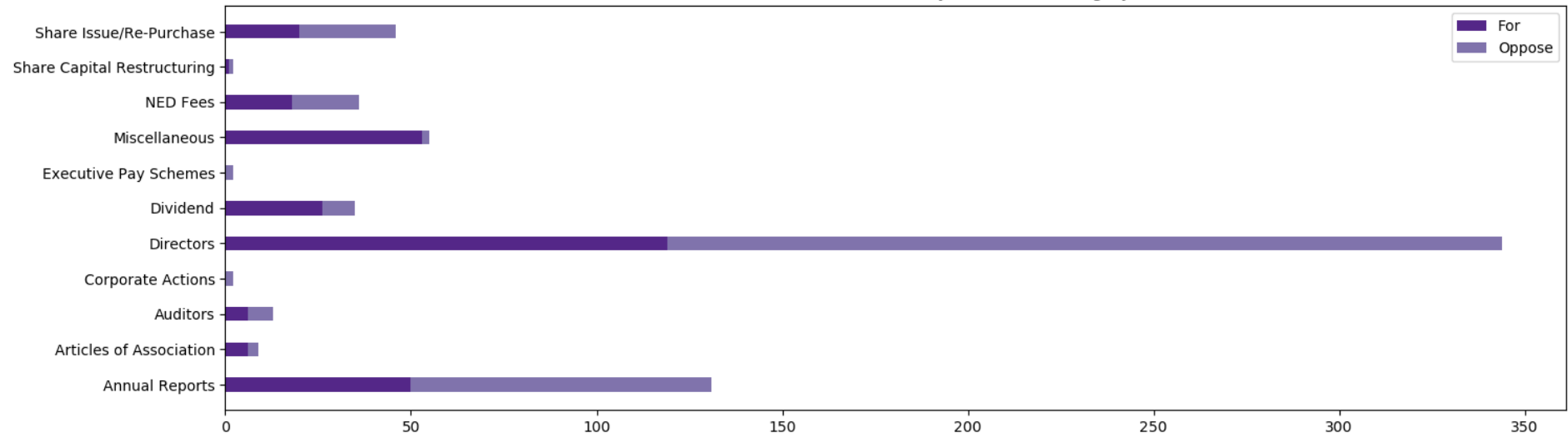
Votes Made in EU & Global EU by Resolution Category

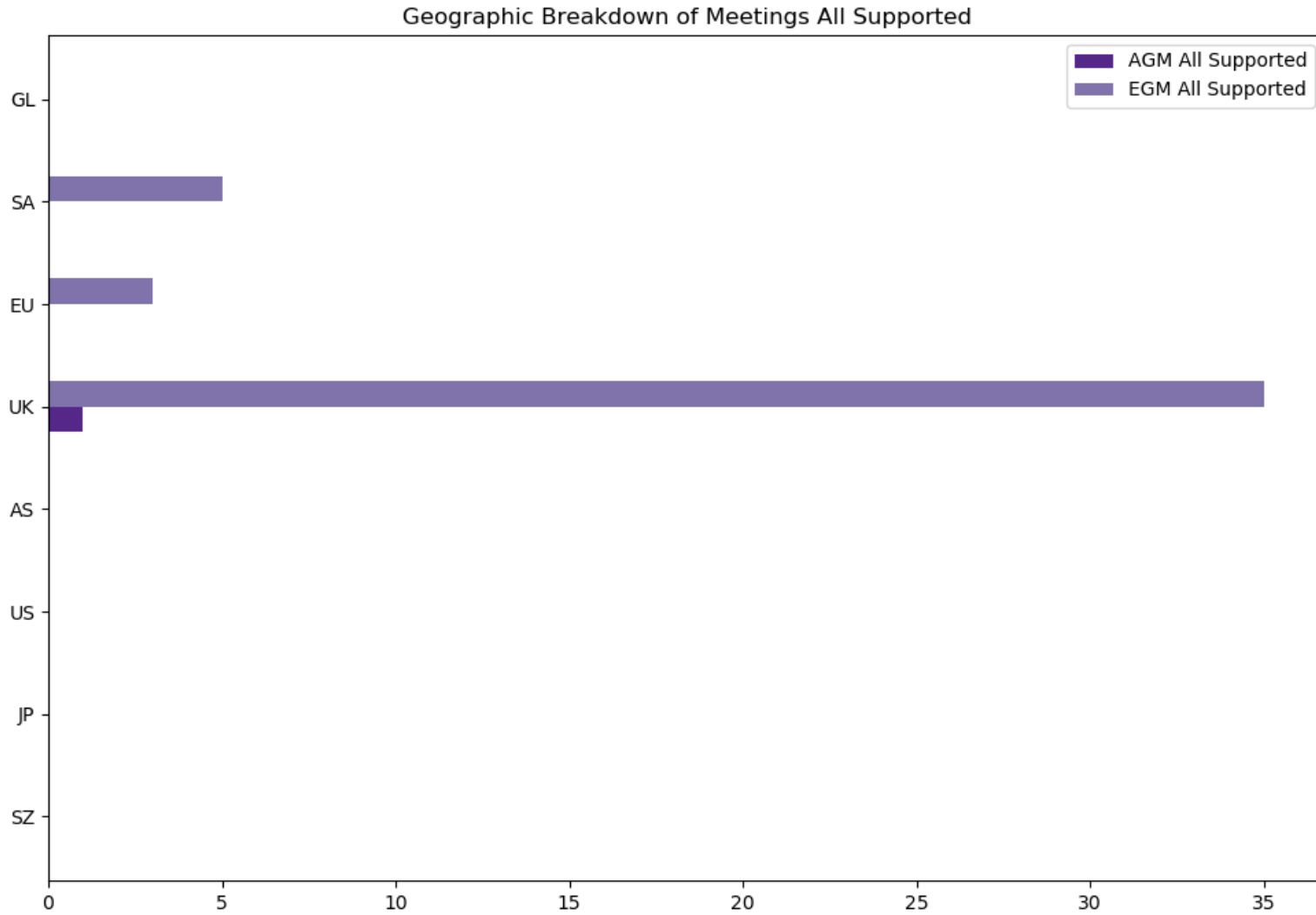
