Provide specialist mental health and substance use input into reablement placements.	Camden ASC and ICB	Proposal submitted to Commissioning. Joint working model with NLMP under consideration.
Produce a guide to working with families to improve practitioner confidence.		A full draft guidance has been developed and circulated to partner agencies for comment. This clarifies roles and good practice for engaging relatives in safeguarding cases.
Promote professional curiosity across safeguarding training and supervision.	SAPB Learning & Development Subgroup	Embedded in training content reviews. Draft revised course materials under review. We have requested that this is included in Camden ASC external trainer for safeguarding.
Influence safeguarding culture across the borough.	SAPB Executive	Reinforced through safeguarding communications and strategy. Reflected in subgroup TORs. SAR findings have been integrated into Level 3 safeguarding training. For example, courses now include modules on fire safety (e.g. emollient and smoke alarm awareness) and self-neglect triggers. Camden fire service liaison continues to raise community awareness.

It incorporates earlier use of civil and criminal powers, in line with SAR recommendations.

Housing partners have started targeted audits of hostel placements, and some hostels have already revised risk assessments to include self-neglect indicators.
Ensure residents are aware of the service offer when entering hostels, including licence agreement terms and access to care pathways.	Camden Commissioning	Resident service offer template under development. Draft in circulation among providers for feedback.
Review multi-agency input into safeguarding plans when people remain at risk in temporary accommodation.	SAPB and ASC	The group endorsed the development of a Camden-specific multi- agency assessment protocol, drawing on SCIE guidance, to strengthen cross-sector assessment practice and ensure consistent decision-making.
Re-launch and embed the co- occurring mental health and substance use protocol.	SAPB and NHS/Voluntary Partners	A new borough-wide protocol (for people with combined mental health and substance-use needs) was endorsed in principle. Drafting is underway under NHS leadership, with borough-wide consultation planned.
Hold a multi-agency meeting to understand the scale of drug use in and around MM's hostel and inform harm reduction strategy.	Community Safety, Public Health, CGL	Multi-agency meeting held July 2025. Key themes escalated to Community Safety Partnership.
