Thanks for letting me know.

I am instructed to offer further concessions to give the residents some peace of mind that their representations are unnecessary.

My client is prepared to amend the start time for the supply of alcohol to midday every day. The sale of alcohol remains ancillary to the provision of a sit down meal at all times. This is not a drink led business.

In addition, I note that there are concerns about the premises becoming a hub for a delivery/take away pizza business. This is not the applicant's intention. He wishes to run a sit down pizza restaurant. Delivery/take away is. Not intended to be a primary activity at the premises. Such activity would disturb the sit down nature of the restaurant. To that end I would propose a condition that the premises shall not use any third party delivery operator such as Deliveroo or Uber Eats.

In the event that a delivery order is received it will be hand delivered by a member of restaurant staff locally. Only a single member of staff shall be used for this service should it prove necessary.
