Camden Town Unlimited is the business representative body for Camden Town. We represent all businesses in the area, including late-night operators, and fund street wardens who work in partnership with the police and local security services to deter crime. Our long-standing position is that policing is a municipal service funded by general taxation. On that basis, we believe the Late Night Levy should be removed.

If the levy is retained, the existing discount for BID members must also remain, because levy-paying businesses that are part of the BID are already contributing to public safety and area improvement through the BID levy. The most effective mitigation for late-night disorder is visible, on-street frontline presence. Therefore, levy funding should not be diverted into training, administration or other non-frontline programs. The full 70% share should continue to go directly to the police, and the remaining 30% should be focused solely on frontline on-street capacity such as accredited private security or CEOs.

From the perspective of local businesses, we do not agree with imposing an additional fee for late-night alcohol sales. Such a policy would increase operating costs at a time when many hospitality businesses are already facing high expenses and narrow profit margins. This could force bars, restaurants, and shops to raise prices or reduce staff, ultimately weakening the local nighttime economy.

Furthermore, customers choose to go out late at night because night-time activities create vibrancy in the city. If additional fees make late-night operations unsustainable, the city may lose tourism revenue and cultural appeal. Local nightlife is an important part of the overall business ecosystem and contributes indirectly to tax income, employment, and public activity.

We also believe that maintaining public safety, including night patrols, is a basic governmental responsibility that should not be funded specifically by late-night alcohol retailers. It would be unfair to assume that alcohol sales alone are responsible for all nighttime security costs. Public safety serves everyone and should not be treated as a private expense borne by businesses.

For these reasons, we respectfully oppose the proposal to impose an extra fee for selling alcohol during late-night hours.

I personally do not feel that the current police patrols are very effective. Over the past few years, I have had my phone stolen several times in this area. Although I reported each incident to the police, none of the phones were ever recovered, and there was no clear follow-up on the cases.

In addition, I work at a restaurant in this neighborhood, and the restaurant's front windows have been smashed more than once. These incidents were also reported to the police, but the same thing kept happening, which suggests that the existing patrols are not preventing repeated crimes.

## Appendix 4

When crimes continue to occur in the same area despite multiple reports, it gives the impression that the police presence is either too limited, not visible enough, or not responding in a way that deters criminal behavior. As residents and workers in the community, we hope to see patrols that are more proactive and effective in maintaining safety rather than requiring businesses to pay extra fees for issues that still remain unresolved.

On top of that, businesses in the area also suffer direct financial losses from theft. In our restaurant, items have been stolen, including alcohol and other property. These losses are paid entirely out of our own pocket, and they occur despite the fact that we have repeatedly reported incidents to the police.

When businesses must continue to cover the cost of stolen goods and property damage, while crime still happens frequently in the same area, it reinforces the feeling that patrols are not effectively preventing or deterring criminal activity. For local business owners, this raises real concerns about safety and fairness, especially if we are now expected to pay additional fees for late-night alcohol sales when current public safety measures are already falling short.

Moreover, late-night refreshment premises are not the primary drivers of alcohol-related disorder or public nuisance, yet the levy would place them in the same category as late-night alcohol venues. This is neither fair nor proportionate. In many cases, takeaway food actually helps reduce disruptive behavior by providing a place for people to eat and sober up before going home.

If local policing and safety measures are already insufficient under the current system, simply expanding the levy does not address the underlying problem. Instead, it risks pushing more small businesses into financial hardship or closure, weakening the nighttime economy and reducing services available to residents.

For these reasons, I do not agree with including late-night refreshment premises in the levy.

It relies on consultation with only 27 stakeholders in a borough of over 250,000 residents and thousands of affected businesses, making the stakeholder evidence anecdotal and non-representative. While the report acknowledges these limitations, it nevertheless draws borough-wide conclusions about fairness, effectiveness and support that the evidence cannot sustain. The accompanying crime data shows mixed and fluctuating trends rather than a clear or attributable reduction in night-time crime, with persistent hotspots remaining across Camden. Taken together, the review functions more as a high-level options paper than a robust impact assessment and does not provide a sound evidential basis for major policy decisions on the Late Night Levy.

The independent review of Camden's Late Night Levy is fundamentally undermined by serious evidential deficiencies. Most notably, it is based on consultation with only 27 stakeholders in a borough of over 250,000 residents and thousands of affected businesses. This level of engagement is wholly inadequate and cannot support borough-wide conclusions about resident experience, business impact, fairness or public confidence. The participation of only two resident associations, without evidence of how many residents they represent, further weakens the legitimacy of the findings.

The business evidence is similarly limited. Only a small number of individual venues contributed directly, and trade association views are included without any quantification of how many Camden businesses they represent or how many are subject to the Levy. Although the review acknowledges these shortcomings, it nevertheless relies on this material to draw substantive conclusions, which is methodologically unsound.

The crime data does not remedy these flaws. While some offence categories show reductions, others increase, and persistent hotspots remain. No statistical testing, control areas or causal analysis is provided to demonstrate that observed changes are attributable to the Late Night Levy rather than wider policing, economic or social factors. Police assertions of effectiveness are not independently tested.

In summary, the review lacks a representative consultation base and a robust analytical framework. It functions as an options or discussion paper rather than a credible impact assessment and does not provide a sound evidential basis for major policy decisions regarding the Late Night Levy.

As discussed, there are venues such as Pirate Studios which to my knowledge don't pay this fee, despite being open late - that's because although a lot of alcohol is consumed there, the alcohol is brought directly by the customers, and consumed on site, rather than sold by the venue. Similar to a BYOB restaurant I presume.

Pirate Studios for example opens until midnight 7 days a week - I call this late night, particularly for weekdays considering it's open 7 days a week. Considering the history of creating ASB from that venue, and their inability / lack of willingness to restrict it by reducing opening hours to more socially acceptable hours as suggested on many occasions, including by the police and councillor Callaghan, I find this unfair they don't pay their share - particularly when you think of the amount of resources they have consumed in the council and the police in the past, and no doubt will continue to consume.

Pirate Studios is a good example of a venue that on the surface looks clean - it's marketed as a music recording studio, which would expect to run daytime only for music professionals, but the reality is very different - they have DJ booths which groups use for late parties, closing at midnight, before they head to the next party, e.g. bars and clubs in London - hanging around in the street, drinking more etc. whilst they gather their groups, before they make their way - often waiting for Uber etc for what feels like forever - particularly when it's repeated by every group, when their booking finishes (e.g. 9pm, 10pm, 11pm, midnight...) and there are many separate groups at the same time - there are 37 individual studios in their venue, so potentially 37 drunk and drugged groups hitting the small residential street at the same time !!
