

APPENDIX D – FEES AND CHARGES FOR 2026/27 WITH SUPPORTING INFORMATION

This appendix outlines those fees and charges for which approval from Cabinet or Full Council is required in order for them to be levied from the 2026/27 financial year.

A number of fees and charges for 2026/27, which were either new or recommended to increase by more than 7%, were agreed by Cabinet in the December 2025 report 'Review of the Council's Medium Term Financial Strategy' (CS/2025/14). This report seeks Cabinet approval and (for certain fees as required by statute) Council approval for the remaining new fees or those proposed to increase by more than 7%. This report also seeks the delegation of authority for approving fees and charges increasing by up to a maximum of 7% to the relevant Executive Director, in consultation with Portfolio Holders.

D1. 2026/27 FEES AND CHARGES REQUIRING CABINET APPROVAL**Fees Requiring Cabinet Approval**

New fees and charges or exceptions where increases are above 7% on the previous year's maximum level are detailed for Cabinet approval, where these have not already been agreed. Supporting information is provided below to explain the exceptional proposals and the reasonableness of the fee or charge.

Fees which require Cabinet approval alone are given in Appendix D1 below, along with supporting narrative explaining each recommended charge. It is also proposed that Cabinet agrees Appendix D2 and recommends it to Council for approval.

Environment & SustainabilityCamden Accessible Transport Solutions

It is recommended to regularise a charge for Registered Disabled Cards through Camden Accessible Transport Solutions (CATS.011), which Cabinet is asked to agree as a new fee.

Engineering

Three new lane rental charges (PLA.1068-1070) are proposed under the New Roads and Street Works Act 1991, in anticipation of a decision on Camden's proposed Lane Rental scheme and expected amendments to the legislation which will enable these fees to be charged by the Council.

Recreation & Public Safety

Community Safety Emergency Management

The Community Safety Enforcement Service is part of Camden's wider approach to keeping neighbourhoods safe and well managed. Their work focuses on dealing with anti-social behaviour and environmental issues that affect day-to-day life, helping to keep public spaces clean, orderly and welcoming. The team works closely with partners such as the police and Council services, using local intelligence and a visible presence to prevent problems, take proportionate enforcement action where needed, and build public confidence in community safety.

The service is authorised to issue Fixed Penalty Notices (FPNs) for a range of low-level offences, mainly linked to environmental crime and public nuisance such as littering and fly-tipping under the Environmental Protection Act 1990. They may also issue FPNs for certain anti-social behaviour-related breaches, for example failure to comply with a Community Protection Notice under the Anti-social Behaviour, Crime and Policing Act 2014. These powers allow the Council to take quick, proportionate action without needing to go straight to court. It is therefore recommended to introduce a number of new charges within Community Safety (CPN.019-030 and CPN.033-036), as well as to recognise several fees for graffiti, flyposting, flytipping and littering which were previously held under Environment Services (CPN.013-018 and CPN.031-032).

D2. 2026/27 FEES AND CHARGES REQUIRING FULL COUNCIL APPROVAL**Fees Requiring Full Council Approval**

Some fees and charges by law also require Full Council approval, including some licensing fees. Licensing fees fall broadly into two categories.

- i. Those set by statute, which the Council has no power to amend.
- ii. Those where the relevant statute gives Councils the power to set their fees in line with cost recovery. A cap may be set by statute in some cases.

This appendix sets out those licensing fees for which Full Council approval is required, should Cabinet choose to agree and recommend these fees to Council.

Digital & Data ServicesContact Camden

Two new registrar fees (CUS.260-261) are proposed for approval by Full Council, to align with statutory fees set by central government. These fees are already set out in legislation, and the service are now seeking to add them to the fees and charges list to enable the provision of these services when required.

Environment & SustainabilityEngineering

A fee for crane oversails (PLA.0234) is recommended to increase by more than 7%. This aligns the charge with an existing charge for Level 2 Crane Operation, given that it is equally impactful, requiring a tower crane erection and agreements to oversail.

Environment Services

Two new street trading fees are proposed, in order to allow traders wanting to trade from an empty neighbouring pitch in a market (STR.006) and in respect of the provision of hot food (STR.007). One further fee (PLA.0428) is also recommended to increase by more than 7%.

Two fees are also recommended for the removal and storage of electric hire bikes for obstructions and posing immediate danger (PLA.1063-1064).
