# 1. Introduction/Background

HMICFRS inspects and monitors the 43 territorial police forces in England and Wales, reporting to the public and their elected representatives on how well the police do their job. Their purpose is to promote improvements in policing and fire and rescue services, to make services safer for everyone and to independently assess the effectiveness and efficiency of police forces and fire and rescues services in the public interest.

## Types of inspection

- Police effectiveness, efficiency and legitimacy (PEEL) assessments The PEEL inspection programme is an assessment of the effectiveness, efficiency and legitimacy of police forces in England and Wales. Its principal aim is to promote improvements in policing. The PEEL assessment provides graded judgments on aspects of forces' performance. It identifies where forces need to improve and helps the public understand how well their force is performing. All forces are subject to this inspection. Greater Manchester Police's (GMP) last PEEL inspection was in 2023.
- National thematic inspections these can vary and will reflect emerging priorities for policing. These inspections look to gather information and understand what constitutes good policing practice and how all forces can achieve it. A sample of forces will often be selected for onsite inspection and evidence gathering.
- Rolling programmes HMICFRS also has an ongoing schedule of inspections and re-inspections which assess services such as child protection and police integrity across all forces.

# 2. Detail

#### 2.1. Most Recent Publications

There has been one HMICFRS report released since July 2025 which have recommended courses of action for police forces. These can take the form of causes of concern (CoC), areas for improvement (AFI) and/or recommendations (recs).

For each published report, GMP prepares a briefing paper which includes an overview of findings and an initial position against all CoC, AFIs and recs for police forces. This is shared with the Deputy Mayor's (DM) Office to inform and assist with the statutory response, as required by Section 55 of the 1996 Police Act.

## 2.2. Current position with recommendations / AFI's

Internally, corporate governance arrangements exist to support the preparations for HMICFRS inspections and to monitor progress and proactively manage the implementation of recs through the HMICFRS Oversight Board. This is chaired by the DCC and attended by key stakeholders from the DM's Office and HMICFRS.

This meeting takes place every two months (monthly from September 2025) and is preceded by a suite of briefings with chief officers across their business portfolios to provide challenge and scrutiny on progress. Within these meetings each CoC, AFI and recommendation is updated by owners and scrutinised by the appropriate Chief Officer.

All of GMP's CoC, AFIs and recs can be viewed on the HMICFRS monitoring portal. Each is assigned a level according to how forces can evidence progress to closure as follows:

Level 1 – Closed and archived by HMICFRS.

Level 2 - Forces are able to close records when they have completed the work, including uploading a letter signed by the Chief Constable.

Level 3 - Forces self-certify that the recommendation is complete, including uploading a letter signed by the Chief Constable. HMICFRS follow-up / verification via the next relevant planned inspection.

Level 4 - No force self-certification. HMICFRS follow-up work conducted via further bespoke fieldwork, with additional support / inspection when appropriate.

# 2.3. Closure process

To provide reassurance, it should be noted that for HMICFRS to consider a force has fully implemented a recommendation or AFI, or for a CoC to be deemed resolved, a portfolio of evidence must be compiled to demonstrate successful and sustainable implementation. A letter to demonstrate this must be to the satisfaction of the HMICFRS Oversight Board and the DCC before submitting for closure to the HMICFRS Monitoring Portal.
