## 1. Introduction/Background

1.1. This briefing provides an overview of the Greater Manchester Strategic Infrastructure Board (SIB) activities, achievements in 2025, and priorities for 2026, as they relate to the Housing First, Planning and Infrastructure Commission. It is structured to support the January 2026 Commission meeting, ensuring members are informed of the latest strategic developments, governance changes, and operational priorities across infrastructure, housing, and planning.

## 2. Strategic Infrastructure Board: 2025 Highlights

2.1 Five highlights have been identified, these are:

### **a. Strengthening Influence and Collaboration**

- The SIB has evolved from a consultee to a direct influencer with regulators (Ofgem, Ofwat) and infrastructure providers, formalizing its role within the Combined Authority and reporting annually to GMCA leaders.
- Regular 1:1 meetings with providers have improved alignment of local and mayoral plans, integrating them into a single strategic pipeline.

### **b. Regulatory Innovation and Street Works**

- The Board's work on Collaborative Street Works was recognized by Ofgem, with the approach adopted for Greater Manchester and considered for national rollout.
- SIB contributed to national regulatory reform, advocating for place-based approaches and removing barriers to infrastructure delivery.

### **c. Digital Infrastructure and AI Growth**

- Advanced Greater Manchester's digital leadership through an AI Growth Zone proposal and a data centre strategy, emphasizing strengths in power, water, and connectivity.
- Engaged with stakeholders (SP ENWL, United Utilities, Environment Agency) to identify spatial priorities for future data centre locations.

### **d. Resilience and Water Management**

- Progressed the Integrated Water Management Plan (IWMP), securing funding for rainwater management and supporting the Sir John Cunliffe review.
- Demonstrated strong partnership working and strategic alignment with national priorities.

### **e. Board Maturity and Governance**

- Undertook a maturity evaluation, developed flexible terms of reference, and committed to annual reporting and longer meetings to address growing complexity.
- Influenced Ofgem's final determinations for NGET and Cadent, unlocking regulatory support for GM's ambitions.

## **3. Priorities for 2026**

3.1 Seven priorities have been identified, these are:

1. Greater Manchester Infrastructure Plan: Outlining priorities and needs aligned to new Mayoral CA statutory requirements, including the Spatial Development Strategy, Integrated Pipeline, and National Infrastructure Pipeline.
2. Collaborative Street Works: Prepare for and begin implementation.
3. Governance of RESP/NESO: Establish relationships for oversight.
4. Water White Paper Response: Engage with Ofwat/Defra.
5. NGET Transmission Delivery: Support strategic priorities.
6. ED3/Ofgem: Strengthen engagement and clarify priorities with SP ENWL.
7. Social Value: Communicate benefits from infrastructure investment
