1 Recommendations

2 Reasons for Recommendations

- 2.1 The Oracle Fusion system is now live and in use across the Council and Sandwell Children's Trust, following the successful implementation of the system and the completion of the 'hypercare' period.
- 2.2 The Programme Completion Report sets out the deliverables of the programme and draws together the lessons learned, to be built into future strategic programmes. Completion of the Programme Completion Report marks the end of the programme and, therefore, the Budget and Corporate Scrutiny Management Board is asked to acknowledge and formally endorse the programme's completion.

3 How does this deliver objectives of the Council Plan?

The vision for the Oracle Fusion Programme is:

"One Council One System. Simpler, quicker, and better Finance, HR and purchasing systems that help us make better-informed decisions and deliver excellent outcomes for residents."

4 Context and Key Issues

- 4.1 In 2019, the Council agreed to replace the current Oracle E-Business Suite on premise system with the modern 'Cloud based' Oracle Fusion system. However, in December 2021, it was formally agreed that the project would be paused.
- 4.2 In 2022, a 'health check' was completed which provided recommendations to ensure that the Oracle Fusion Project to follow was set up for a successful implementation. In September 2022, a new 'system integrator' was appointed, and the Oracle Fusion Programme commenced with a fresh implementation in October 2022.
- 4.3 The Oracle Fusion Programme achieved a successful 'Go-Live' of the new system in October 2024, following a 2-year implementation process. In December 2024, following a 3-month aftercare phase (known as 'hypercare'), the Programme Board approved the closure of the project, after demonstrating successful completion of the 'hypercare exit criteria'.
- 4.4 The Programme followed a structured methodology and acted on lessons learned and the recommendations provided in the 2022 health check. The Programme Completion Report provides a summary of the Programme's objectives, deliverables, and lessons learned for future strategic programmes.
