






#### Q2 What is the postcode of your main home or business address?



#### Q3 Thinking about the PSPO area, to what extent do you think that the following behaviours are a problem?








# Q5 Do you agree or disagree with the proposal to extend the PSPO in the south of the Borough in the area defined on the map until September 2025?





### Q6 Do you agree or disagree with the proposal to extend the PSPO in the north of the Borough in the area defined on the map until October 2025?





### Q7 If you disagree, do you think that a PSPO should be introduced covering a smaller geographical area?





#### Q8 Do you agree or disagree with the proposal to extend the PSPO and to make a single borough-wide order until September 2025?





### Q9 If you disagree, do you think that a PSPO should be introduced covering a smaller geographical area?


