1. SUMMARY

- 1.1 Admission arrangements for all schools are required to be determined annually by the approving body. The London Borough of Waltham Forest is the admissions authority for all community and voluntary controlled schools within the borough.
- 1.2 This report seeks approval for the proposed admission arrangements for community and voluntary controlled schools in Waltham Forest for 2023-24.

2. **RECOMMENDATIONS**

Cabinet is recommended to:

2.1 Approve the school admissions determined arrangements for 2023/24 for community and voluntary controlled schools at Appendix A.

3. PROPOSALS

3.1 Under the School Admissions (Admission Arrangements and Coordination of Admission Arrangements) (England) Regulations 2012 (as amended in 2014) and as set out in the School Admissions Code



- 2021, all admission authorities must determine their admission arrangements by 28 February every year, even if they have not changed from previous years and a consultation has not been required.
- 3.2 Admission arrangements include the overall procedure, practices and oversubscription criteria used in deciding the allocation of school places.
- 3.3 All admission authorities must participate in the normal rounds of coordination by the Local Authority, but any non-community or voluntary controlled school is permitted to conduct their own in-year allocations.
- 3.4 In 2020 a consultation was carried out on changes to the Determined School Admission arrangements for community and voluntary controlled schools in Waltham Forest for the year 2022-23, which were approved by Cabinet on 23 February 2021. No changes are proposed to the admission authorities' School Admission Arrangements.
- 3.5 As the Local Authority is the admission authority for all community and voluntary controlled schools within the borough, the oversubscription criteria that are set out in Appendix A will apply to all of those schools.
- 3.6 Academies, including free schools, voluntary aided and foundation schools are their own admission authority and must determine their own admission arrangements in line with statutory requirements.

4. OPTIONS & ALTERNATIVES CONSIDERED

- 4.1 Determining the admission arrangements on an annual basis is a statutory requirement.
- 4.2 Not determining the admission arrangements would put the Local Authority in breach of its statutory duty.

5. SUSTAINABLE COMMUNITY STRATEGY PRIORITIES (AND OTHER NATIONAL OR LOCAL POLICIES OR STRATEGIES)

- 5.1 The Community Strategy promotes economic, social, and environmental well-being of the local area.
- 5.2 Ensuring that children are allocated a school place while adhering to the School Admissions Code is an essential element to this strategy.

6. CONSULTATION

- 6.1 The regulations and School Admissions Code 2021 specifies that a statutory consultation is required where a change is proposed for admission arrangements.
- 6.2 There are no proposed changes that require consultation. There is a



requirement to consult at least once every seven years even if no changes are proposed. The last consultation was carried out last year for the determined arrangements 2022/23. Consultation is therefore not required.

7. RESET

- 7.1 Earlier this year the Council approved its Strategic Reset priorities and delivery programme to recover from the pandemic and build a bright future for all in Waltham Forest.
- 7.2 A key priority area within the Reset is a commitment to supporting families, children, young people, and older people. This is underpinned by a number of projects including best start in life and achieving outstanding outcomes for children.
- 7.3 The proposed admission arrangements for community and voluntary controlled schools in Waltham Forest set out in this paper are key to both of these in clearly setting out the overall procedure, practices and oversubscription criteria used in deciding the allocation of school places.

8. IMPLICATIONS

8.1 Finance, Value for Money and Risk

8.1.1 There are no direct financial implications arising from this report.

8.2 Legal

- 8.2.1 Under the School Admissions (Admission Arrangements and Coordination of Admission Arrangements (England) (Amendment) Regulations 2014 all admission authorities must determine their admission arrangements by 28 February every year, even if they have not changed from previous years and a consultation has not been required. The School Admissions Code 2021 (the Code) was issued under Section 84 of the Schools Standards and Framework Act 1998 and came into force on 1 September 2021 and also applies to admission arrangements to be determined in the school year 2023/24 and any future years.
- 8.2.2 The authority must determine their admission arrangements on or before 28 February and publish their admission arrangements by 15 March 2022.
- 8.2.3 Under the Code once admission arrangements have been determined for a particular school year, they cannot be revised by the admission authority unless such revision is necessary to give effect to a mandatory requirement of the Code, admissions law, a determination of the Adjudicator or any misprint in the admission arrangements.

8.3 Equalities and Diversity

8.3.1 The School Admissions Code 2021 promotes equality and adhering to the regulations and Code will ensure the Local Authority supports



complies with its' obligations under the Equality Act 2010. An Equality Act screening has been undertaken (Appendix B), which determined that there was no potential for negative impacts on equality groups as a result of the proposed admission arrangements.
